SCHOOL POOL RENOVATION

Bids to provide 'Venice High School Pool Renovation' were received from four vendors on October 12, 2017. The bid was awarded to Aqua Doc Pool Clinic, LLC on November 5, 2017 as a memo notification to the Assistant Superintendent Chief Financial Officer as the bid was under the bid threshold necessary for Board approval. The bid of Aqua Doc Pool Clinic, LLC was withdrawn by the bidder. The bid of Infinite Pool Finishes, LLC was the next best low bid meeting the advertised specifications. Reasons for not selecting the apparent low bids are included with the bid tabulation. This bid is for a one-time purchase to renovate the existing Venice High School swimming pool. Funds for these purchases are contained in the transfer from capital budget allocated to the Facilities Services Department.
