

**AGREEMENT**  
**The School Board of Sarasota County, Florida**  
and  
**AMikids, Inc.**  
**AMikids Sarasota County**

This Agreement is made and entered into this 6<sup>th</sup> day of December 2011, between The School Board of Sarasota County, Florida, a body corporate under the laws of the State of Florida (the "School Board") and AMikids, Inc., a Florida not-for-profit corporation ("AMikids").

**WHEREAS**, AMikids operates a program known as AMikids Sarasota County.

**WHEREAS**, AMikids Sarasota County is approved by the School Board as an alternative program for Department of Juvenile Justice students, training and related services in accordance with State Department of Education Rules and Sections 1001.42(4)(j), 1003.52 and 1003.53, Florida Statutes; and

**WHEREAS**, the School Board wishes to provide an appropriate program of education and training for Department of Juvenile Justice students assigned to AMikids Sarasota County; and

**WHEREAS**, the School Board believes that, in accordance with State Board Rules, AMikids can meet the educational and training needs of the Department of Juvenile Justice students at AMikids Sarasota County by providing a school program which emphasizes basic skills instruction, the acquisition of course credits toward graduation, vocational training and appropriate attitudinal skills.

**NOW, THEREFORE**, in consideration of the mutual promises and covenants herein contained, and other valuable consideration, the parties to this Agreement hereby agree as follows:

1. This term of this Agreement shall commence December 31, 2011, and terminate June 30, 2012.
2. During the time period commencing December 31, 2011, and ending January 31, 2012, the School Board grants AMikids the right to use the property located at 1130 Indian Hills Blvd, Venice, FL 34293, for the sole purpose of operating the program for students assigned by the Department of Juvenile Justice at AMikids Sarasota County at that location. Thereafter, AMikids will provide and utilize its own facility located at 1844 17<sup>th</sup> Street, Sarasota, Florida 34236.

3. The School Board agrees to pay AMIkids for services as follows:

3.1 The School Board agrees to pay AMIkids for the Sarasota County resident, Department of Juvenile Justice students enrolled at AMIkids Sarasota County as if those students were enrolled in a basic program or a special program in a school in the School District, adjusted for the requirement of a 250-day program for the students placed by the Department of Juvenile Justice. The basis of the funding shall be the sum of the School Board's operating funds from the Florida Education Finance Program (FEFP) as provided in Section 1011.62, Florida Statutes, and the General Appropriations Act, including gross state and local funds, discretionary lottery funds and funds from the School District's current operating discretionary levy, divided by the total funded weighted full-time equivalent students (WFTE) in the School District; multiplied by the weighted full-time equivalent students at AMIkids Sarasota County.

3.2. If AMIkids Sarasota County students or programs meet the eligibility criteria in law, AMIkids shall be entitled to its proportionate share of categorical program funds included in the total funds available in the FEFP by the Legislature. Federal and State categorical appropriations will be expended through the appropriate School Board accounts to insure compliance with applicable grant restrictions.

3.3. Total funding for students enrolled in AMIkids Sarasota County shall be recalculated during the year to reflect the revised calculations under the FEFP by the State and the actual WFTE students reported by AMIkids during the full-time equivalent survey periods designated by the Commissioner of Education.

Additionally, funding to AMIkids shall be adjusted during the year as follows:

3.3.1. Based on supplemental academic instruction (categorical) funding, an adjustment will be determined yearly for the AMIkids Sarasota County program. This adjustment will take into account the number of Department of Juvenile Justice students served and provide additional weight for each student served. This additional weighted FTE will not exceed the weight that is provided by the state for dropout prevention students and will be set yearly by the School District's budget office with input from the AMIkids Sarasota County staff. The weighted FTE will be based on reviewing current weighted FTE and any adjustments made by the state for the Base Student Allocation.

3.3.2. In the event of a state holdback or a proration, which reduces School Board funding, AMIkids funding will be reduced proportionately.

3.3.3. In the event that the School Board exceeds the state cap for WFTE for Group 2 programs established by the Legislature resulting in unfunded WFTE for the School Board, then AMIkids funding shall be reduced to reflect its proportionate share of any unfunded WFTE.

3.4. The School Board shall make every effort to ensure that AMIkids receives timely and efficient reimbursement on or about the 15th of each month.

3.5. The School Board shall retain an administrative fee of 5% of the funds generated through the FEFP described above in paragraphs 4.1, 4.2 and 4.3, and an additional \$1,000.00 for the services of a registrar to enter student information on the Automated Student Information Data System.

3.6. In any programs or services provided by the School Board which are funded by federal funds and for which federal dollars follow the eligible student, the School Board agrees, upon adequate documentation from AMIkids, to provide AMIkids with an appropriate share of the federal funds received by the School Board if the same level of service is provided by AMIkids, provided that federal law or regulation does not prohibit this transfer of funds.

4. AMIkids shall be responsible for administration of and all decisions related to AMIkids Sarasota County. Such administration shall be in cooperation with the School Board's designated administrator and shall be conducted in accordance with agreed upon guidelines, policies and rules.

5. AMIkids agrees that:

5.1 AMIkids Sarasota County will interview each Department of Juvenile Justice student and his/her parent(s)/guardian(s) to review the student's background and records to ensure a successful experience.

5.2 Unless exceptional circumstances warrant, Department of Juvenile Justice students enrolled at AMIkids Sarasota County prior to or during an academic semester shall remain at AMIkids Sarasota County until the completion of the academic semester. Notwithstanding the foregoing, students may be readmitted to a regular school program of the School District at any time with the agreement of the School Board. The parties agree to confer when appropriate in order to allow Department of Juvenile Justice students enrolled at AMIkids Sarasota County to re-enter the School District's regular school program when it appears to be in the student's best interest to do so. Students eligible to return to a School District regular school program shall be evaluated by School Board personnel prior to re-entering the School District's regular school program.

5.3 AMIkids shall develop a School Improvement Plan in compliance with F.S. 1001.42(18) and 1003.53(2)(b) in the format prescribed by the School Board. AMIkids shall be responsible for meeting student performance goals as defined in the School Improvement Plan for improving student achievement.

5.4 All instructional personnel should have professional or temporary state teaching certifications or statements of eligibility. In the event that non-certified personnel are placed in an instructional position, the personnel must possess documented knowledge and/or skill in the field(s) they are instructing. AMIkids must follow the School Board's policy for the approval and use of non-certified instructional personnel.

5.5 AMIkids shall document that parents have been notified in writing when a teacher is teaching subject matter which is outside the field in which the teacher is certified.

5.6 AMIkids Sarasota County's instructional program shall consist of 250 days of instruction, or its hourly (1200) equivalent, of which twenty (20) days may be used for teacher training/planning, distributed over twelve (12) months as required by Section 1003.01(11), F.S.

5.7 Some students referred for enrollment in the program may be identified as disabled under the provisions of the Individuals with Disabilities Education Act ("IDEA") and/or Section 504 of the Rehabilitation Act, and the implementing federal and state regulations. These students are entitled to receive necessary special education and related services as are appropriate to address their individual needs.

AMIkids agrees to provide the regular classroom educational services mandated by each student's IEP and to follow each student's IEP in providing educational services through properly certified or certifiable teachers. AMI further agrees to require the attendance of AMIkids Sarasota County staff at IEP and other meetings when requested by School Board employees to: (1) provide the School Board with all necessary information and feedback about the appropriateness of each student's program and necessary changes to each student's IEP; (2) refer students for evaluation and testing when requested by parent(s) or when AMIkids Sarasota County personnel believe a student may be in need of such services; (3) provide information to the School Board as necessary for School District personnel to evaluate students; (4) notify the School Board when students are in need of re-evaluation or changes in and review of IEP's; and (5) comply with federal and state mandates regarding the suspension or expulsion of special needs students. AMIkids further agrees to assure that the AMIkids Sarasota program is accessible to disabled students and in compliance with the mandates of the Americans with Disabilities Act.

5.8 AMIkids shall provide ESOL instruction for those students identified by the School Board as ESOL students.

5.9 AMIkids shall maintain student records in accordance with State Board Rules and Exceptional Student Education, ESOL students and Florida Education Finance Program rules. Additionally, all information for data reporting requirements requested by the School Board and State and Federal agencies must be maintained. Failure to maintain records required for an audit may result in forfeiture of earned FTE payments.

5.10 AMIkids shall fully comply with Section 1002.22, Florida Statutes, and School Board procedures to protect the confidentiality of student record information, and it assures that It shall provide the parents, or the students who are eighteen (18) years of age or older, the rights of access, copies, amendments and hearings as specified in State Board Rule 6A-1.0955, F.A.C.

5.11 It is understood that all School District Department of Juvenile Justice students transferred to AMIkids Sarasota County shall remain students of the School District for enrollment reporting in accordance with state laws. AMIkids shall take daily attendance of all students at AMIkids Sarasota County. AMIkids shall provide weekly attendance records for each student in

AMIkids Sarasota County, including absences, enrollments and withdrawals.

5.12 AMIkids shall develop an Individual Educational Plan for each student that shall meet the requirements of State Board Rules.

5.13 AMIkids assures that it complies with the Civil Rights Acts of 1964, Title IX of the Education Amendments of 1974 and Section 504 of the Rehabilitation Act, and shall at all times comply with local and state standards for the health and safety of students.

5.14 AMIkids assures the School Board that it does not discriminate on the basis of race, sex, marital status, national origin, religion, handicap, sexual orientation, or age in the operation of its business or provision of services.

5.15 AMIkids shall designate a staff member to be responsible for the administration of the provisions of this Agreement and for the supervision of the program.

5.16 AMIkids shall place emphasis on survival skills, goal setting, vocational skills and the achievement of socially acceptable behavior patterns. The curriculum shall reflect approved courses in the Florida State Course Code Directory. All high school courses provided will meet the School District's pupil progression plan for promotion and a high school diploma.

5.17 AMIkids shall maintain complete and accurate records with respect to all matters covered under this Agreement. The School Board's Superintendent or designee shall have free access to such records during regular business hours, and the right to examine and audit the same and to make transcripts therefrom, and to inspect all program data, documents, proceedings, and activities. The parties will conduct periodic reviews to insure that AMIkids Sarasota County meets the quality standards of the School Board.

5.18 AMIkids shall submit the grades and credits earned for each student to the School Board and the student's parent/guardian as the grades and credits are carried, at the end of each grading period, or at the date of withdrawal of each student from AMIkids Sarasota County. AMIkids shall notify the School Board immediately of any disciplinary proceeding instituted by AMIkids against any student at AMIkids Sarasota County, which may result in long-term suspension or expulsion from AMIkids Sarasota County. Following the opportunity for notice and hearing to be conducted in accordance with the School Board's rules for expulsions, AMIkids shall be entitled to expel from AMIkids Sarasota County any student who is found to be disruptive to the program or who is found to be threatening intimidating to any other student or employee. AMIkids shall also notify the School Board whenever a Department of Juvenile Justice student will be returning to his/her districted school placement.

5.19 AMIkids shall assure that each of its employees assigned hereunder has been fingerprinted by an authorized law enforcement agency and processed by the State Department of Law Enforcement and the Federal Bureau of Investigation for criminal background checks. Any employee assigned hereunder must meet level 2 screening requirements as described in section 1012.32, Florida Statutes. The results of all such background investigations and fingerprinting shall be reported in writing to the Superintendent of Schools.

5.20 AMIkids agrees to observe and to be bound by School Board Rules, policies and procedures as they apply to teacher-pupil relationships and all other aspects of the AMIkids Sarasota County program herein agreed to by the parties.

5.21 AMIkids shall comply with all School Board rules regarding purchasing, ordering supplies from the School Board's warehouse, textbook ordering, the processing of library media materials, and the marking and inventory of fixed assets valued at \$750.00 or greater.

5.22 AMIkids agrees that use of School Board site/facilities at 1130 Indian Hills Blvd, Venice, FL, during the time period specified in paragraph 2 above, is solely for the purpose of operating an alternative education program known as AMIkids Sarasota County. AMIkids shall be responsible for providing all custodial services while it is operating the AMIkids Sarasota County program at 1130 Indian Hills, Blvd., Venice, FL.

6. Written procedures of intake, evaluation, dismissal, and transition of students in the AMIkids Sarasota County program that are in compliance with applicable provisions of State Board Rules shall be cooperatively developed between the School Board and AMIkids and implemented at AMIkids Sarasota County.
7. The students at AMIkids Sarasota County shall adhere to a Code of Student Conduct mutually agreed upon by the School Board and AMIkids.
8. Supervision and control of the students while in the AMIkids Sarasota County program shall be the sole responsibility of AMIkids.
9. AMIkids shall indemnify and hold harmless the School Board from any and all liability for any claims, including attorney fees, demands, or judgment made or recovered against the School Board because of personal injuries or damages suffered by any person arising out of, or incidental to, the performance or failure to perform by AMIkids of its obligations hereunder, or arising from the operation of AMIkids Sarasota County as contemplated herein, whether or not such damages or injuries are alleged to have arisen out of the sole or partial negligence of AMIkids, or its officers, directors, agents, employees, students or invitees. In addition, AMIkids shall indemnify, protect and hold the School Board harmless against all claims and actions brought against the School Board by reason of any actual or alleged infringement of patent or other proprietary rights in any material, process, machine or appliance used by AMIkids.

This indemnification and hold harmless agreement shall survive the termination or expiration of this Agreement. AMIkids shall notify the School Board of any claim promptly upon receipt of same. The School Board shall have the option to defend, at AMIkids's expense, any claims arising under this provision. If the School Board does not choose to hire its own counsel to defend, AMIkids shall assume the defense of any such claim and the School Board shall delegate complete authority to AMIkids in the defense thereof. Nothing herein shall be construed as a waiver of the School Board's sovereign immunity.

10. AMIkids shall maintain at all times during the term of this Agreement, the following insurance coverage:

- 10.1 Commercial general liability in the amount of \$1,000,000 per occurrence, \$1,000,000 aggregate;
- 10.2 Professional liability in the amount of \$500,000 per each claim, \$2,000,000 aggregate;
- 10.3 Workers' Compensation pursuant to Florida Statutes;
- 10.4 Employer's liability.

The School Board shall be named as an additional insured on the commercial general liability on a primary basis with respect to any liability for damages or injuries suffered by any person as a result of the performance or failure to perform by AMIkids, of its obligations hereunder. AMIkids shall provide the School Board with a certificate of insurance evidencing compliance with the terms of this paragraph. Such certificate shall note on its face that the insurer shall notify the School Board, in writing, thirty (30) days prior to the lapse of the insurance.

- 11. The School Board will provide coordination in the development of a transition plan for each entering and exiting student, including an IEP on each ESE student. The development of a revised IEP for entering ESE students, annual IEP reviews and three year re-evaluations will be coordinated with School District staff in consultation with AMIkids Sarasota County staff.
- 12. AMIkids may arrange for transportation of AMIkids Sarasota County students through a separate agreement with the School Board's Transportation Services Department or by other means agreeable to the School Board. AMIkids may also enter into a separate agreement with the School Board to receive additional transportation services for extracurricular events, field trips, and other activities.
- 13. AMIkids shall comply with the federal requirements for free and reduced meal service. AMIkids may utilize the School Board for the provision of free and reduced meal service. The parents of students eligible for free or reduced priced meals must complete an application and submit it to the School Board's Food and Nutrition Services Department for review and processing. AMIkids shall be responsible for picking up meals or may contract with the School Board for delivery. If AMIkids desires meal service for students not eligible for free or reduced priced meals, the School Board will provide such meals at the regular rate per

student. If meal service is utilized, AMIkids and the School Board's Food and Nutrition Services Department shall enter into a separate agreement.

14. The School Board or AMIkids can terminate this Agreement without cause at any time after giving the other party thirty (30) days written notice. If any termination occurs during the time period that AMIkids has the right to use the School Board's property pursuant to paragraph 2 above, AMIkids's right of use of the property at 1130 Indian Hills Blvd, Venice, FL 34293 shall cease and AMIkids shall vacate the premises.
15. It is mutually understood and agreed that AMIkids is at all times acting and performing as an independent contractor in the performance of all obligations hereunder. The School Board shall not withhold, or in any way be responsible for the payment of any federal, state or local income or occupational taxes, FICA taxes, unemployment compensation or workers' compensation contributions or any other payments for or on behalf of AMIkids to any of its employees unless specifically set forth herein.
16. AMIkids shall, at its own expense, obtain such business or professional licenses as may be required by any local, state, or federal agency in connection with AMIkids's business and obligations herein, and shall provide copies of all such licenses to the School Board.
17. This Agreement may be modified or amended only in writing by mutual consent of the parties.
18. This Agreement shall be construed and enforced in accordance with the laws of the State of Florida, the rules and regulations of the State Board of Education, and the rules and policies of the School Board. Sole and exclusive jurisdiction for all conflicts and disputes shall be in the County or Circuit Court for the 12<sup>th</sup> Judicial Circuit in and for Sarasota County, Florida.
19. This Agreement can be terminated for breach of the covenants set forth herein. Termination of the Agreement for breach shall be effective upon giving ten (10) days written notice of the breach of the Agreement and termination thereof.
20. Any notice given pursuant to this Agreement shall be made by hand delivery or first class mail as follows;
