SR72 Walking Description Corrections

LAKEVIEW ELEMENTARY SCHOOL:

From I-75 east on Bee Ridge on a continuation of Bee Ridge Road to a point west of Utopia Road. Southeast to an apex at the termination of Utopia Road, the north east to the imaginary continuation of Bee Ridge Road and east to the northern boundary of Myakka River State Park. Follow the northern boundary of Myakka River State Park to the Sarasota/Manatee County line. South on the Sarasota/Manatee County line to the southern termination. East on Sarasota/Manatee County line to its termination then south on Sarasota/DeSoto County line to the North Port City Limits. Follow the City Limits westward to their termination, then northwest to the southwest corner of Myakka State Park. Then northwest to the extension of Central Sarasota Parkway. West from this point to an intersection and I-75 and the extension of Central Sarasota Parkway. North on I-75 to Bee Ridge Road.

LAUREL NOKOMIS SCHOOL: [NOTE: this description is for this K-8 school's elementary (K thru 5) grades only] From Little Sarasota Bay and North Creek outlet, southeast on North Creek to U.S. Highway 41. North on U.S. Highway 41 to Central Sarasota Parkway. East on Central Sarasota Parkway with an imaginary extension to the southwest corner of Myakka State Park. Then southwest to the northwest corner of the City Limits of North Port. Then West the Sarasota/Manatee County line. Continuing east on the Sarasota /Manatee County line to the Sarasota/Desoto County line. South on Sarasota/DeSoto County line to a point due east of Border Road. West on an imaginary extension of Border Road to Border Road. West on Border Road to the Myakka River. North on the Myakka River to a point due east of Palm Drive. West on imaginary line to Palm Drive and continue west to imaginary extension of Jackson Drive. South on imaginary extension of Jackson Drive to Border Road. West on Border Road to Venice city limits (both sides of Border Road in Taylor Ranch). North, then west then, south along Venice city limits to an imaginary junction with Curry Creek. West through Curry Creek to South Roberts Bay. Follow South Roberts Bay to its outlet on Gulf of Mexico. North through Gulf of Mexico, then through Midnight Pass to Little Sarasota Bay and North Creek outlet. Includes all of Casey Key.

SARASOTA MIDDLE SCHOOL:

From the intersection of Beneva Road and Bee Ridge Road, east on Bee Ridge Road to its termination. East on the imaginary extension of Bee Ridge Road to the northern boundary of the Myakka River State Park. Continue east along northern boundary the Myakka River State Park to the Sarasota/Manatee County line. South along the Sarasota/Manatee County line to its termination, then east on the county line to the Sarasota/DeSoto County line. Go South to the City Limits of North Port. Follow the City Limits westward to their termination, then northwest to the southwest corner of Myakka State Park. Then northwest to the extension of Central Sarasota Parkway, then West on Central Sarasota Parkway a point due east of Central Sarasota Parkway. West from this point on an imaginary line to Central Sarasota Parkway. West on Central Sarasota Parkway to U.S. 41. North on U.S. 41 to Beneva Road. North on Beneva Road to Bee Ridge Road.

VENICE HIGH SCHOOL:

From Little Sarasota Bay and North Creek outlet, southeast along North Creek to U.S. 41. North on U.S. 41 to Central Sarasota Parkway. East on Central Sarasota Parkway, then southeast to the southwest corner of Myakka State Park. Go southwest to the northwest corner of the City Limits of North Port. - extending as an imaginary line to Sarasota/Desoto County line. South on

Sarasota/DeSoto County line to the eastward extension of the north boundary of the North Port City Limits. West to the junction of the Myakka River and the extension of Border Road. South along Myakka River to a point due east of Manasota Beach Road. West from this point along imaginary extension of Manasota Beach Road, then Manasota Beach Road to Belvidere Road. West on Belvidere Road to Gulf of Mexico. North through Gulf of Mexico to Midnight Pass. East through Midnight Pass to Little Sarasota Bay and North Creek outlet.

Excludes all of Manasota Key.

RIVERVIEW HIGH SCHOOL:

From North Roberts Bay, east on Tangier Way to Bay Road (both sides of Tangier Way in Riverview). East on Bay Road, then continuing east on Bee Ridge Road to McIntosh Road. South on McIntosh Road to Proctor Road. East on Proctor Road, across Interstate 75 and southeast to the southeast property line of Bent Tree subdivision. North along that property line to its junction with Bee Ridge Road. East on Bee Ridge Road to its intersection with Bee Ridge east on an imaginary line to its intersection with the northern boundary of Myakka River State Park. Follow along the northern boundary of Myakka River State Park to Sarasota/Manatee County line. South and then east on the Sarasota/Manatee County line, then south and east to the Sarasota/DeSoto County line. Go South to the City Limits of North Port, then west to their termination. Then northwest to the southwest corner of Myakka State Park, then northwest to the imaginary extension of Due east of Central Sarasota Parkway. West on an imaginary line from this point to Central Sarasota Parkway. West on Central Sarasota Bay. North through Little Sarasota Bay to North Roberts Bay. North along North Roberts Bay to a point east of Tangier Way.

Includes the area from Whitaker Bayou and Dr. Martin Luther King, Jr. Way, east on Dr. Martin Luther King, Jr. Way to U.S. Highway 301 (North Washington Boulevard). South on U.S. Highway 301 to 10th Street. West on 10th Street to U.S. Highway 41 (North Tamiami Trail). North on U.S. Highway 41 to Whitaker Bayou. Northeast along Whitaker Bayou to Dr. Martin Luther King, Jr. Way.
