- \* (2) Direct and coordinate program planning to involve District and school personnel, community representatives and students when appropriate.
- \* (3) Assist school personnel in initiating and implementing new programs.
- \* (4) Assist in school improvement initiatives.
- \* (5) Assist schools in keeping abreast of state mandates, District initiatives and opportunities for participation in grants or special programs.
- \* (6) Provide assistance for the development and implementation of performance standards.
- \* (7) Provide assistance for the implementation of the District's Pupil Progression Plan.
- \* (8) Serve as the District contact for the Southern Association of Colleges and Schools accreditation

process.

- \* (9) Assist school principals, as needed, in the recruitment, selection, placement and appraisal of school-based personnel.
- \*(10) Assist in the development of administrative guidelines for high school education programs.
- \*(11) Assist in the development of policies for high school education programs.
- \*(12) Maintain a close working relationship with school administrators to ensure information exchange, coordination of efforts and general support for the decision-making process.
- \*(13) Work with schools and District personnel in obtaining information regarding the effectiveness of program implementation.

- \*(17) Supervise the District expulsion process, including the development of standards and procedures consistent with law, student/parent rights and school safety.

- \*(19) Organize Assistant Principal meetings.
- \*(20) Work with athletic directors to develop District procedures and to promote equity in programming for secondary school students.
- \*(21) Ensure visibility on school campuses during the school day and at extracurricular activities.
- \*(22) Direct the Summer School Program for middle school students.
- \*(23) Assist in the interpretation of programs, philosophy and policies of the District to staff, students and the community.
- \*(24) Interact with parents, outside agencies, business and community to enhance understanding of District initiatives and priorities and to elicit support and assistance.
- \*(25) Keep the Superintendent informed, through proper channels, of potential problems or unusual events.
- \*(26) Work closely with District and school staffs to support school improvement initiatives and processes.
- \*(27) Maintain expertise in assigned areas to fulfill project goals and objectives.
- \*(28) Facilitate the development, implementation and evaluation of staff development activities in assigned areas.
- \*(29) Develop annual goals and objectives consistent with and in support of district goals and priorities.
- \*(30) Attend training sessions, conferences and workshops to keep abreast of current practices, programs and legal issues.
- \*(31) Direct the development of the secondary school budgets and assure that expenditures are in accordance with budget allocations and the District's strategic plan.
- \*(32) Supervise assigned personnel, conduct annual performance appraisals and make recommendations for appropriate employment action.
- \*(33) Prepare or oversee the preparation of all required reports and maintain appropriate records.
- \*(34) Serve on District, state or community councils or committees as assigned or appropriate.
- \*(35) Represent, consistently, the District in a positive and professional manner.
- \*(36) Utilize appropriate strategies and problem-solving tools to make decisions concerning planning, utilization of funds, delivering services and evaluation of services provided.
