## ADDENDUM TO MEMORANDUM OF UNDERSTANDING-CAREER ADVISORS BETWEEN SUNCOAST WORKFORCE BOARD, INC. AND

## THE SCHOOL BOARD OF SARASOTA COUNTY, FLORIDA

THIS ADDENDUM is entered into this \_\_\_\_\_ day of January, 2008, by and between the Suncoast Workforce Board, Inc. ("SWB") and The School Board of Sarasota County, Florida (the "School Board").

## RECITALS

- A. The parties hereto entered into an agreement to delineate the relationship and responsibilities between the parties regarding specific workforce services provided to students at high schools in Sarasota County under the Career Advisor program developed by the parties, (the "Agreement") on June 19, 2007.
- B. The Agreement provides for reimbursement from the School Board to SWB under "RESPONSIBILITIES," sub-heading, "The School Board of Sarasota County, Florida shall:", paragraph numbered 9, at the rate of \$28,496.45 per month for eleven months from July 1, 2007, through May 31, 2008, for a total reimbursement of \$313,460.95.
- C. The parties hereto desire to modify the Agreement set forth in the responsibilities of the School Board, paragraph number 9 referred to in paragraph D above, by increasing the total funds to be reimbursed from \$313,460.95 to \$322,864.78. Said increase shall be paid as set forth below.

NOW, THEREFORE, in consideration of the sum of One Dollar, receipt of which is hereby acknowledged, and other valuable consideration, the parties do hereby agree as follows:

I. The reimbursement to SWB under the Agreement, paragraph number 9 of the Responsibilities of the School Board, is increased by \$9,403.83, for a total of \$322,864.78. The increase of \$9,403.83 shall be paid as follows: one lump sum payment of \$5,129.38 upon approval of this Addendum by the School Board, and an increase in the monthly reimbursement for months January 2008 through May 2008 in the amount of \$854.89 per month.

Accordingly, the reimbursement rates for January 2008 through May 2008 shall be increased to \$29,351.34 per month.

- II. The parties acknowledge and agree that the remainder of the terms of the Agreement shall remain in full force and effect during the term of this Addendum.
- III. Where there is any conflict between the terms of this Addendum and the Agreement, the terms of this Addendum shall control.
