It is the intent of Microsoft that the donation be in compliance with all applicable laws, regulations and ethics rules regarding gifts and donations, as well as the ethics policies of any downstream recipients of the Product(s). Microsoft makes this donation without seeking promises or favoritism for Microsoft in any bidding arrangements. Further, no exclusivity will be expected by either party in consideration for the donation. Microsoft makes the donation with the understanding that it will not as a result of such donation be prohibited from any procurement opportunities or be subject to any reporting requirements.

Sarasota County Schools may use the Microsoft name and logo(s) only to identify the Product(s) or to identify Microsoft as a donor of the Product(s). Sarasota County Schools may not change the packaging, Product(s), printed materials, Microsoft trademarks, trade names, or trade address as they appear in and on the Product(s). Sarasota County Schools is not granted any right, title, interest or license in or to any Microsoft trademarks.

Sarasota County Schools may not state or imply that Microsoft is responsible for conducting or administering the Program in any way. Sarasota County Schools agrees to obtain Microsoft's written approval before it makes any public statement related to Microsoft's contribution to the Program.
