Bids to provide 'Sarasota High School Theatrical Lighting System and Controls Replacement' were received from three vendors on June 25, 2014. The bid of Candela Controls, Inc., was the best low bid meeting the advertised specifications. The funds for this purchase are contained in the capital budget allocated for the project.

Recommended Motion: That the bid of Candela Controls, Inc., to provide 'Sarasota High School Theatrical Lighting System and Controls Replacement' in an amount not to exceed \$150,000.00, be approved as presented.

The bidder proposes and agrees to provide a "not to exceed" price for installation, labor, materials, supervision, equipment, tools, fuel, removal of refuse from SBSC property, disposal of refuse fees, etc., to perform the work required in accordance with the bid documents as specified, the theatrical lighting, controls replacement, and electrical specifications, and drawings as prepared by ME3 Consulting Engineers, LLC. Special requirement of this bid will be for the Contractor to complete the project with the least disruption to the educational process, which may require working after normal school hours. The SBSC reserves the right to direct purchase all or part of the materials from the materials supplier and deduct this cost, plus the taxes from the theatrical lighting, controls replacement, and electrical 'not to exceed' price.
