SERVICE

The bids of All Around Charters, Escot Bus Lines, LLC, First Class Coach Company dba Martz Group, Florida Breakaway Charters, LLC, Florida Trails, Inc., dba Annett Bus Lines, Sarasota Coach Lines, Inc., and SEC Bus Inc., dba All Aboard Charters, were the best low bids meeting the advertised specifications.
