SECOND ADDENDUM TO CONTRACT FOR EDUCATIONAL SERVICES PINNACLE ACADEMY, INC.

THIS SECOND ADDENDUM is entered into this 5th day of June,
2007, by and between The School Board of Sarasota County,
Florida, a body corporate under the laws of the State of Florida
(the "Board") and Pinnacle Academy, Inc.

RECITALS

- A. The parties hereto entered into a contract for educational services for eligible exceptional students (the "Contract") on July 19, 2006, expiring June 30, 2007.
- B. The parties are contemporaneously entering into an Addendum to Contract dated June $5^{\rm th}$, 2007 (the "Addendum"), adding extended school year services for June 2007 and increasing the total reimbursement for services not to exceed \$ 198,775.00.
- C. The parties hereto desire to modify the Contract to permit services to be provided during an Extended School Year (ESY) during July 2007 for up to an additional 17 school days and 3 school days during August 2007, and to provide compensation therefor under the following terms and conditions.

NOW, THEREFORE, in consideration of the mutual promises made herein, the parties do hereby agree as follows:

- 1. Paragraph 4C of the Contract is amended so that it shall now terminate on August 3, 2007.
- 2. Paragraph 3D of the Contract is amended to include an additional provision of Extended School Year (ESY) Educational Services for an additional 17 school days during July 2007 and 3 school days during August 2007. Compensation shall be at the rate of \$39.00 per student per day for 17 school days during July

2007 and 3 school days during August 2007 for a total of 20 school days.

- 3. Paragraph 3D of the Contract is further amended so that the ESY services in July and August 2007 may be compensated as stated in paragraph 2 above. The cost of these additional ESY services shall not exceed \$11,700.00, and shall be in addition to any other amounts already listed in paragraph 3D.
- 4. The parties acknowledge and agree that the remainder of the terms of the Contract and Addendum thereto shall remain in full force and effect during the term of this Second Addendum.
- 5. Where there is any conflict between the terms of this Second Addendum, the Addendum and the Contract, the terms of this Second Addendum shall control.
