Proposed edits for Dunnhill Estates-

RIVERVIEW HIGH SCHOOL:

From North Roberts Bay, east on Tangier Way to Bay Road (both sides of Tangier Way in Riverview). East on Bay Road, then continuing east on Bee Ridge Road to McIntosh Road. South on McIntosh Road to Proctor Road. East on Proctor Road, across Interstate 75 and southeast to the just south of Willow Leaf Drive to the northwest boundary of Dunnhill Estates. Then northeast and turning southeast to follow the rear property lines of all lots included in Dunnhill Estates then to the southeast property line of Bent Tree subdivision. North along that property line to its junction with Bee Ridge Road. East on Bee Ridge Road to its intersection with Bee Ridge east on an imaginary line to its intersection with the northern boundary of Myakka River State Park. Follow along the northern boundary of Myakka River State Park to Sarasota/Manatee County line. South and then east on the Sarasota/Manatee County line to the Sarasota/DeSoto County line. Due east of Central Sarasota Parkway. West on an imaginary line from this point to Central Sarasota Parkway. West on Central Sarasota Parkway to U.S. 41. South on U.S. 41 to North Creek. Northwest along North Creek to Little Sarasota Bay. North through Little Sarasota Bay to North Roberts Bay. North along North Roberts Bay to a point east of Tangier Way.

Includes the area from Whitaker Bayou and Dr. Martin Luther King, Jr. Way, east on Dr. Martin Luther King, Jr. Way to U.S. Highway 301 (North Washington Boulevard). South on U.S. Highway 301 to 10th Street. West on 10th Street to U.S. Highway 41 (North Tamiami Trail). North on U.S. Highway 41 to Whitaker Bayou. Northeast along Whitaker Bayou to Dr. Martin Luther King, Jr. Way.

SARASOTA HIGH SCHOOL:

From the junction of Main Street at Lower Main Street, east to the Seaboard Coast Line Railroad tracks (eastern). North along the railroad tracks to Fruitville Road. East on Fruitville Road to I-75. South on I-75 to Palmer Boulevard. East on Palmer Boulevard to Iona Road. South on Iona Road to Delft Road. East on Delft Road to its termination. South on an imaginary line to its intersection with an imaginary extension eastward of Bee Ridge Road. (Both sides of Palmer Boulevard, Iona Road and Delft Road are in Booker High School. All of Laurel Oaks is in Sarasota High School). East on Bee Ridge Road to the northeast property line of Bent Tree subdivision. South along that line to a point that meets the southeast corner of the Dunnhill Estates Subdivision. Follow along all of the rear lot lines to a point just south of Willow Leaf Drive and then turn southwest to at its the intersection with of Proctor Road. West on Proctor Road, across Interstate 75, and west to McIntosh Road. North on McIntosh Road to Bee Ridge Road. West on Bee Ridge Road to Bay Road. West on Bay Road to Tangier Way to North Roberts Bay (both sides of Tangier Way are in Riverview district). South through North Roberts Bay and Little Sarasota Bay to Midnight Pass. West through Midnight Pass to Gulf of Mexico. North through Gulf of Mexico to Big Pass. Northeast through Big Pass, Sarasota Bay and Island Park to an imaginary junction with Lower Main Street. (This includes all of Siesta Key and Marina Plaza.) Northeast on Lower Main Street to Main Street.

Includes area from U.S. Highway 301 (North Washington Boulevard) at 47th Street, east on 47th Street to Carmichael Avenue. South on Carmichael Avenue to Myrtle Street (both sides of Carmichael Avenue to Sarasota High School). Southeast from intersection of Carmichael Avenue and Myrtle Street to a point just east of Newtown Estates (include Newtown Estates only). South from this point to Dr. Martin Luther King, Jr. Way. East on Dr. Martin Luther King, Jr. Way to Tuttle Avenue. South on Tuttle Avenue to 17th Street. West on 17th Street to U.S. Highway 301. North on U.S. Highway 301 (North Washington Boulevard) to 47th Street.
