Proposed edits for Myakka Estates Subdivision-

ENGLEWOOD ELEMENTARY:

From the Gulf of Mexico at the northern tip of Manasota Kay, east to the drainage canal south of Ponderosa Road. East along the canal to State Road 776. South to the storm water pond south of Pierce Drive. East through the pond to its end. South along the eastern property line of the Pennington Place subdivision to Manasota Beach Road, east on an imaginary line to the Myakka River just south of the Myakka Estates Subdivision. South, southeast along Myakka River to the Sarasota/Charlotte County line. South along the Sarasota/Charlotte County line to the Gulf of Mexico. North to the northern tip of Manasota Key. Includes all of Manasota Key. Also includes that portion of Charlotte and Lee Counties as approved by the Charlotte, Lee and Sarasota County School Boards.

VENICE MIDDLE SCHOOL:

From Venice Inlet through Roberts Bay to Curry Creek, east along Curry Creek to the imaginary junction with the Venice city limits. Follow the Venice city limits east, then north to include all of Capri Isles subdivision and Waterford subdivision, then east and south along Venice city limits to Border Road. East on Border Road to Jackson Road. North on Jackson Road to Palm Drive. East on Palm Drive to its termination. East from the terminus of Palm Drive to the Myakka River. (Both sides of Border Road and all streets with access from Border Road are included in Venice Area Middle School.) South along Myakka River to a point due just southeast of Manasota Beach Road (<u>All of the Myakka Estates Subdivision is in Venice Middle School</u>). Northwest from this point to the intersection of an along-imaginary extension of Manasota Beach Road to Belvidere Road. West on Belvidere Road along an imaginary extension to the Gulf of Mexico. North through the Gulf of Mexico to Venice Inlet.

Excludes all of Manasota Key, whose students are districted to L. A. Ainger Middle.

VENICE HIGH SCHOOL:

From Little Sarasota Bay and North Creek outlet, southeast along North Creek to U.S. 41. North on U.S. 41 to Central Sarasota Parkway. East on Central Sarasota Parkway extending as an imaginary line to Sarasota/Desoto County line. South on Sarasota/DeSoto County line to the eastward extension of the north boundary of the North Port City Limits. West to the junction of the Myakka River and the extension of Border Road. South along Myakka River to a point due just southeast of Manasota Beach Road (All of the Myakka Estates Subdivision is in Venice High). Northwest from this point to the intersection of an along imaginary extension of Manasota Beach Road, then Manasota Beach Road to Belvidere Road. West on Belvidere Road to Gulf of Mexico. North through Gulf of Mexico to Midnight Pass. East through Midnight Pass to Little Sarasota Bay and North Creek outlet.

L. A. AINGER MIDDLE SCHOOL:

Pursuant to a long-standing agreement with Charlotte County Schools, Sarasota County's middle school students living south of Manasota Beach Road, along an eastward imaginary extension to River Road just south of the Myakka Estates <u>Subdivision</u>, and then to the Charlotte County line, are districted to L. LEMON BAY HIGH SCHOOL:

Pursuant to a long-standing agreement with Charlotte County Schools, Sarasota County's high school students living south of Manasota Beach Road, along an eastward imaginary extension to River Road just south of the Myakka Estates <u>Subdivision</u>, and then to the Charlotte County line, are districted to Lemon Bay High.
