

**THIRD ADDENDUM TO CONTRACT FOR EDUCATIONAL SERVICES**  
**Easter Seals Southwest Florida, Inc.**  
**D/B/A The Lily School for Child Development**

THIS THIRD ADDENDUM is entered into this 1st day of May 2018, by and between The School Board of Sarasota County, Florida, a body corporate under the laws of the State of Florida ("the Board") and Easter Seals Southwest Florida, Inc. ("THE LILY SCHOOL").

R E C I T A L S

A. The parties hereto entered into a contract for educational services for eligible exceptional students (the "Contract") on July 18, 2017, expiring June 30, 2018, for services through May 2018, which was modified by an Addendum dated August 15, 2017.

B. The parties are contemporaneously entering into an Second Addendum to Contract dated May 1, 2018, adding extended school year services for June 2018 and increasing the total reimbursement for services not to exceed \$38,834.90.

C. The parties hereto also desire to modify the Contract to permit services to be provided during an Extended School Year (ESY) during July 2018 for up to an additional 8 school days and to provide compensation therefor under the following terms and conditions.

NOW, THEREFORE, in consideration of the mutual promises made herein, the parties do hereby agree as follows:

1. Paragraph 4C of the Contract is amended so that it shall now terminate on July 31, 2018.

2. Paragraph 3D of the Contract is amended to include an additional provision of Extended School Year (ESY) Educational Services for an additional 8 school days during July 2018. Compensation shall be at the rate of \$65.00 per student per day for 8 school days during July 2018.

3. Paragraph 3D of the Contract is further amended so that the ESY services in July 2018 may be compensated as stated in paragraph 2 above. The cost of these additional ESY services for July 2018 shall not exceed \$1,4400.00, and shall be in addition to any other amounts already listed in paragraph 3D.

4. The parties acknowledge and agree that the remainder of the terms of the Contract, Addendum, and Second Addendum thereto shall remain in full force and effect during the term of this Third Addendum.

5. Where there is any conflict between the terms of this Third Addendum, the Addendum, Second Addendum, and the Contract, the terms of this Third Addendum shall control.
