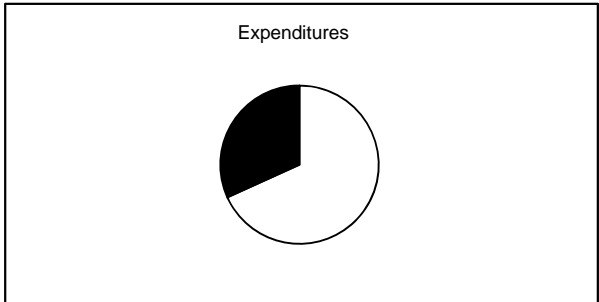


Food Service Fund

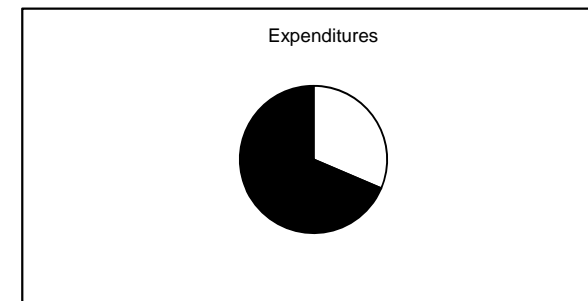
