Action Plans for Elementary Schools	<p>Chris Renouf and Kelly Ellington presented a brief overview of the data. What happened? What are we doing about it?</p> <p>When reviewing and dissecting the 2018 FSA data, we noticed the following patterns/trends:</p> <ul style="list-style-type: none"> • Plus: increases in Science (Elementary Level Science Specialist added), increases in Math; and • Delta: decreases in ELA, learning gains, lowest quartile, Tier I instructional concern in Reading/English and Language Arts <p>District Elementary Team is working in concert with all of our schools to provide support in a variety of ways. Together, working hand in hand, side by side, we will continue to make a positive difference and life-long impact in the lives of our students, staff and families.</p> <p>Discussion ensued between the Board Members, Chris Renouf and Kelly Ellington.</p> <p>The principal of each "C" grade school will discuss specific increases and decreases in the 2018 FSA data, contributing factors or impacts that led us here, and sharing of action plans for 2018-2019 for their school.</p>
