The bids of O'Dell, Hall and Associates, Inc., dba Walrus Construction as a primary vendor and Norstar Construction, Inc., as a secondary vendor were the best low bids meeting the advertised specifications. These services will be used on a district-wide basis for maintenance and repairs and includes work necessary for relocating portable classrooms. This bid is for a period of one year with the option to renew for two additional one-year periods. The funds for these services are contained in the capital budgets allocated to the Construction Services and Facilities Services Departments.
