# The School Board of Sarasota County, Florida Workshop August 16, 2011 Sharing Referendum and Capital Dollars with New Charter Schools

#### Current Capital Outlay allocation to Charter Schools

Beginning with the 2008-2009 fiscal year a portion of capital millage funds were distributed to charter schools. The reasons for distributing the funds was made based upon the students are Sarasota public education students, their parents are taxpayers, and the funding from the Florida Education Finance Program is inadequate to fund the total operation of a school. The formula for distribution to the Capital Millage to the charter schools was based upon the percentage of charter school weighted student FTE as compared to the total district weighted FTE. This is the same manner in which the Florida Education Finance Program funds are distributed to the charter schools. The percentage of the millage funds eligible for distribution was and still is 30% of the millage levy. The 30% was arrived at by looking at what percentage of the millage levy went to recurring maintenance and equipment costs for the district. Below is a comparison of the current allocation of capital funds to the charter schools for the fiscal year 2011-2012.

#### **Total Operating Fund Allocation**

The state requires charter school sponsors to distribute the revenues earned through the Florida Education Finance Program based upon the formulas used in the calculation of the FEFP program. The formulas are based upon both student weighted FTE and student unweighted FTE. In 1996 when the charter school legislation was passed the district sponsor was allowed a five percent administrative fee on the total revenues earned by the charter school. Since that time the administrative fee has been limited to five percent of the first 250 students. Charter schools that are designated as high performing have the administrative fee reduced to 2% of the first 250 students. Sarasota charter schools that have been designated as high performing are Sarasota Arts and Sciences and the Venice Leadership Academy. In the below table are the allocations that the charter schools are estimated to receive for the 2011-2012 fiscal year.


