## AGREEMENT FOR AFTER SCHOOL SNACK PROGRAM SARASOTA YMCA/SARASOTA SUNCOAST ACADEMY

This Agreement is made and entered into this \_\_\_\_\_ day of August, 2009, by and between The School Board of Sarasota County, Florida, a body corporate under the laws of the State of Florida (the "School Board"), The YMCA Children, Youth and Family Services, Inc., a Florida not-for-profit corporation ("Sarasota YMCA"), and the Sarasota Suncoast Academy ("Sarasota Suncoast"), a charter school in Sarasota County, Florida.

## WITNESSETH:

WHEREAS, Sarasota YMCA provides an After School program at Sarasota Suncoast; and

WHEREAS, Sarasota YMCA and Sarasota Suncoast is desirous of a snack program in conjunction with the After School program; and

WHEREAS, the School Board's Food and Nutrition Services Department has the capability to provide a snack program.

NOW, THEREFORE, in consideration of the foregoing and the covenants contained herein, the parties agree as follows:

1. The School Board, in cooperation with Sarasota YMCA and Sarasota Suncoast, shall make snacks available to children enrolled in the After School program at Sarasota Suncoast at a charge of \$.74 for students with a paid meal status, \$.37 for students eligible to receive reduced priced meals, and no charge for students eligible to receive free meals under current National School Lunch Program (NSLP) guidelines.

2. The term of this Agreement shall be for a period of ten (10) months, commencing on August 24, 2009, and terminating on June 10, 2010, unless sooner terminated as provided herein.

3. The snack service shall be in accordance with United States Department of Agriculture, (U.S.D.A.) snack requirements, as set forth in the "After School Snack Menu Requirements."

4. The School Board Food and Nutrition Services manager at Lakeview Elementary School shall receive daily snack counts from Sarasota YMCA After School personnel. Sarasota YMCA After School personnel shall gather and submit information, following procedures outlined under the National School Lunch Program After School Snack Program. Actual snack counts will be submitted to the Food and Nutrition Services Manager on a daily basis for invoicing to Sarasota YMCA. Snacks ordered but not recorded as being received by a child will be invoiced at \$.80 per snack. 5. Sarasota Suncoast personnel shall be responsible each day for picking up the snacks prior to the close of the cafeteria at Lakeview Elementary School and for properly storing them at Sarasota Suncoast until they are consumed by students in the after school program.

6. Sarasota YMCA shall remit payment to the School Board to the attention of the Director, Food and Nutrition Services Department, 101 Old Venice Road, Osprey, Florida 34229, within thirty (30) days of receipt of invoices.

7. Sarasota YMCA shall indemnify and hold harmless the School Board from and against all liabilities, claims, demands, suits, causes of action, loss and expenses including attorneys fees, of any and every kind and nature arising from the negligent or intentional act of agents or employees of the Sarasota YMCA in connection with the provision of snacks under this Agreement.

Sarasota Suncoast shall indemnify and hold harmless the School Board from and against all liabilities, claims, demands, suits, causes of action, loss and expenses including attorneys fees, of any and every kind and nature arising from the negligent or intentional act of agents or employees of the Sarasota Suncoast in connection with the provision of snacks under this Agreement.

Nothing herein shall be deemed to constitute a waiver of sovereign immunity on the part of the School Board or to reduce any protection from suit or judgment afforded to the School Board under Florida law. This provision shall survive termination of this Agreement and shall be binding on the parties, successors, representatives and assigns and cannot be waived or varied.

8. This Agreement may be terminated without cause by any party upon thirty (30) days' written notice.

9. Any notice given pursuant to this Agreement shall be as follows:

10. This Agreement represents the entire agreement of the parties hereto and no prior or subsequent oral agreements shall be binding upon either of the parties until reduced to writing.
