


Original BAC Process for Woodland MS

- Formed September 2006
- Made recommendations March 2007
 - Keep exiting 5th graders together
 - Start the new school with fewer than half of North Port's middle school membership
 - so not to overwhelm a new school
 - because the eastern part of North Port was growing so much faster

Predicted Growth Patterns

Policy 7.78(3)

- Responsibility to maximize the utilization of facilities
 - Over-utilized and Under-utilized
 - Options
 - School Choice and Reassignments
 - Cluster programs
 - Redistrict
 - Expand permanent capacity of over-utilized schools

- Section III provides a process to re-draw attendance zones
 - □ due to changes in population
 - □ for new schools
 - □ to assure efficient use of school facilities

Policy 5.20 [cont.]

Guidelines

- Keep neighborhoods intact
- Allow for growth
- Minimize the impact
- Avoid redistricting students multiple times
- Grandfather" students with one year remaining

2011 BAC Considerations

- Determine the number of students to move
- Ensure equity of school offerings
- Analyze the effect on
 - School bus transportation costs
 - Free/Reduced Meal Percentages
 - Test scores & School Grades
- Any other issue

- Map of Elem. feeder pattern
- Middle School capacities
- Middle School mobility reports
- Imagine Charter School impact
- Charter Schools forecast


Data Considered [cont.]

- Lamarque and Cranberry 5th grade enrollments
- Residential development trends
- Enrollment data for neighborhoods "on the border"
- Major roads and waterways to be used as natural boundaries

Proposal

- Redraw the Heron Creek and Woodland attendance zones as depicted, effective June 2012
- Allow current HCMS 7th graders and their 6th and 5th grade siblings <u>only</u> to remain, without school bus transportation
- Allow no School Choice for either school for the 2012-13 school year

Proposed Redistricting Map- North Port Middle Schools



Estimated Impact

- Approximately <u>139-189</u> students would transfer to Woodland for next school year
 - Based on <u>252</u>5th-7th graders in the affected area, @ a 75% assignment rate [=189 students]
 - Minus an estimated 50 students taking advantage of grandfathering
- By the 2013-14 SY, and without other factors, the yearly change would be <u>185</u>.

Unintended Consequences on Schools

- We predict
 - No additional school transportation costs
 - No affect on school grades
 - No affect on percentage of students on Freeor Reduced-Meal status

Communications Thus Far

- Posting of all Agendas and Minutes to district home page
- Notification letters to
 - 82 5th graders' parents in the affected area
 162 6th and 7th graders' parents in the area
- Posting of proposal on Lamarque, Heron Creek, Long Range Planning, and district websites

November 29th Public Forum

- Invitations sent to 244 parents, plus notices on multiple websites
- Attended by four parents and one City Commissioner
- Issues
 - Lack of transportation for grandfathering
 - Enrollment impacts of charter schools
 - HCMS and WMS music programs

 - 2009 redistricting of Toledo Blade for the opening of Atwater
 - 2009 redistricting of Tatum Ridge and Brentwood zones
