Dear George,

As requested, I am providing the hours that BMK has spent working with the Construction Services Department and the District's staff in making changes to the High School Prototype for Venice High School.

The scope of services included the following work from March 3, 2008 to December 4th 2008 when I was directed by you to stop work. The scope of work listed below is not included in BMK's contract with the School Board for Master Plan Services of Venice High School.

SMALL LEARNING CENTERS (SLC):

- Redesign the small learning centers to change the student stations from 350 students to 404 students.
- b. Reduce science laboratories from three per SLC to two.
- c. Reduce the administration office areas from one per SLC to one per floor or one per two SLC's.

PERFORMING ARTS THEATER / AUDITORIUM:

- a. Redesign the prototype auditorium to meets the needs of the City of Venice and Venice music community needs.
- Attend design meetings with the City of Venice, Venice Music community, and Sarasota School Board staff to review and establish basic floor plans and design criteria.

VENICE HIGH SCHOOL CAMPUS PROGRAM REQUIREMENTS:

- Reduce the number of student stations and Small Learning Communities from a. 2950 to 2200 to 2400 student stations. .
- b. Add a Career Technical Educational Lab (CTE) for culinary arts adjacent to the main kitchen of the school.
- c. Relocate the Performance Based Diploma Classrooms from offsite to on site within the new high school.
- Relocate Full Time ESE classrooms from prototype to classroom building or second floor of new administration. (existing media building.)
- Review and edit the revised Educational Specifications for new high school. е.

REDUCE COSTS AND SQUARE FOOTAGE OF THE RIVERVIEW PROTOTYPE

- a. Delete the second floor to the music building, Venice High School music program is not a large as at Riverview High School.
- b. Delete the second floor classrooms at the gymnasium.
- c. Delete the third floor of the classroom building to eliminate 2 Small Learning Centers.
- d. Delete the second floor covered walkway adjacent to the music, auditorium, and gymnasium.
- e. Provide concept plans showing the remodeling of the existing media center into the new administration building with the option of a second floor.
- f. Delete the balcony, covered dining balcony and raised outdoor dining balcony at dining/cafeteria building.
- g. Delete two story entry canopy of prototype and replace with aluminum walkway canopy.
- h. Delete Paul Rudolph's design elements of Riverview prototype.
- Provide revised schematic plans and help W.G. Mills to determine a new cost estimate for the new Venice High School.

ADAPT PROTOTYPE HIGH SCHOOL FOR EXPANSION OF ONE TO TWO FUTURE SMALL LEARNING CENTERS.

a. Revise prototype to allow for future SLC's either one story or two story blocks.
