Re: Charter School Application Review Findings for the State College of Florida Collegiate School A+STEM at Venice

In December 2011, the district received its first collegiate charter school application, submitted by the State College of Florida (SCF), for the Collegiate School A+STEM charter school to open on the Venice campus in the fall of 2012. As you know, F.S. 1002.33 provides for Florida college institutions to establish charter schools that offer secondary education and the option for students to receive an AA degree upon high school graduation. Unlike K-12 charter school applications, Florida College System applications are not subject to the same time lines and may be evaluated and approved by the district School Board at any time during the year.

The district Charter Review Committee (CRC) met on January 19 and January 26, 2012 to review the SCF application for its compliance with statute and its evidence of meeting standards necessary for the operation of a high quality charter school. The CRC followed the state guidelines and used the Florida Department of Education Charter School Application Evaluation Instrument to evaluate and rate each of the 19 standards.

The CRC provided the initial findings and feedback to the applicant on January 31, 2012. The SCF charter applicant was provided the opportunity to clarify or amend the application based upon the CRC's feedback and did so on February 8, 2012. In addition, SCF representatives met with the CRC on February 9, 2012 to review the additional information provided and to address or clarify any other concerns expressed by the committee.

The attached summary chart and the CRC evaluation findings reflect the comments of CRC members and the applicants themselves as well as summary findings and ratings reflective of the extent to which the CRC believes the standards have been met in the application. Hopefully, these comments will be helpful to you as you prepare for your workshop with the SCF Collegiate School A+STEM charter applicant next Tuesday, February 21, 2012. The applicant is aware that the Board may have additional questions that they may be called upon to address.

The agenda item related to School Board approval/denial of this application is scheduled for the February 21, 2012 School Board meeting.
