JOB GOAL

To provide a safe and secure environment for District personnel and protect District facilities and equipment through careful monitoring of security and plant automation systems.

PERFORMANCE RESPONSIBILITIES:

- * (1) Coordination and scheduling of work associated with system monitoring and shift staffing
- * (2) Due to the critical nature of this job work hour and shift adjustments may be required, and Board approved paid and non-paid holidays may not follow the published calendar.
- * (3) Assists with processing telephone account modifications and invoices.
- * (4) Assists with processing facility management system data.
- * (5) Monitor security, fire alarm, and voice communication systems.
- * (6) Analyze situations immediately and take the appropriate action.
- * (7) Make sure the proper authorities are advised of emergencies as discovered through monitoring devices.
- * (8) Be alert to impending disasters; such as, storms.
- * (9) Serve as central communications point for emergencies and disasters.
- * (10) Maintain appropriate records on all activities of the center.
- * (11) Serve as bus dispatcher after hours as required.
- * (12) Be detail-oriented in receiving information and dispatching information.
- * (13) Demonstrate initiative in the performance of assigned responsibilities.
- * (14) Provide for a safe and secure workplace.
- * (15) Model and maintain high ethical standards.
- * (16) Follow attendance, punctuality and proper dress rules.
- * (17) Maintain confidentiality regarding school matters.
- * (18) Maintain positive relationships with staff.
- * (19) Participate in workshops and training sessions as required.
- * (20) Keep supervisor informed of potential problems or unusual events.
