B.1 ADDITIONAL SERVICES

B.1.1 The City of North Port requires the parent parcel to be platted to accommodate the 5 outparcels for the bank and the remaining parcel for the STC campus. This effort includes the preparation of the Development Master Plan based on input and direction from the City of North Port. This effort also includes the design and permitting of the utility infrastructure that will serve the 5 outparcels including water, sanitary sewer, lift station, force main and the storm water management system. The access driveway is also included in this effort with improvements to Cranberry Boulevard to accommodate turn lanes shall not exceed: **\$104,500.00**.

B.1.2 Preliminary Development Plan for City of North Port including Arboreal Review, preliminary tree protection and removal required street tree and buffer plan concept. Plat for City of North Port including detailed tree removal plan, mitigation calculations for tree removal, and buffer planting plans with irrigation plans for buffer and irrigation pump station design shall not exceed: **\$18,700.00**.

B.1.3 Life Cycle Cost Analysis shall not exceed: \$7,040.00

B.1.4 Design and Construction Administration services for the addition of a Food Service Consultant to design the Culinary Arts Program including Kitchen and associated support service spaces that was moved from Phase 2 of the project to Phase 1. Cost not to exceed: <u>\$34,760.00</u>.

B.1.5 & 1.6 Design and Construction Administration services for modifications/reductions to the square footage and other building modifications to reduce the projects budgets for STC and the County Library. Cost not to exceed: **<u>\$98,265.00.</u>**

B.1.7 Provide additional architectural services for the development and reconciliation of the overall project's space program including all related educational requirements. Cost not to exceed: **<u>\$17,740.00.</u>**

B.1.8 Design and Construction Administration services to upgrade the dining area to a Conference Center per Article 2.a. in the Interlocal Agreement between the School Board of Sarasota County and the City of North Port dated June 2, 2015. Cost not to exceed: **<u>\$65,000.00</u>**.

B.1.9 Changes to previously accepted designs of the underground fire line piping, fire hydrant location, addition of a fire hydrant backflow preventer and additional underground fire line to the Chiller Building along with a required fire sprinkler system for the building. These modifications were requested by the North Port Fire Department. Cost not to exceed: **\$4,735.00**.

B.1.10 Design services to the addition of numerous fire alarm pull stations throughout the buildings as requested by the North Port Fire Department. Cost not to exceed: <u>\$2,870.00.</u>

B.1.11 Design and Construction Administration services for the re-design of the Building #02 Industrial Arts Labs, Rooms 2-104 and 2-106, revising the location of selected equipment and associated electrical power requirements. Cost not to exceed: **\$9,375.00**.

B.1.12Design services for the modification of all gas operated equipment from LP gas to Natural Gas and modification to all gas piping systems. Cost not to exceed: <u>\$4,430.00.</u>

B.1.13 Design services for the additional effort required during the design and pre-construction phases of the project to establish the program area which increased square footage and ultimately the final cost. This additional work effort is based upon total hours necessary to complete the design phase of the project. Cost not to exceed: <u>\$379,667.00.</u>

SchenkelShultz is submitting this proposal request to amend the Basic Services Agreement Between the Owner and Architect by the following Scope of Work modifications.

Initially, during the commencement of the Fee negotiations, the project's program area and construction budget was approximately 40,000 gsf and \$13,325,000.00 for construction cost. Our negotiated Basic Service Fee was based on these parameters. During the design process and at our Team meeting on October 6, 2015, the project program and building area had increased from the initial project scope to approximately 100,00 gsf. At this time , the Construction Management firm submitted a preliminary construction cost of approximately \$ 19, 051,756.00. It was agreed that the building program area would be decreased with the anticipation of a reduced construction value.

In our discussions of November 3, 2016, it that decided and mutually agreed that with the Construction Management firm continuing with the process of developing a final GMP for the project, we would all wait until a final GMP was approved and then review our amendment request for Additional Services. The Construction Management firm developed a final construction cost for the project of \$ 21,139,813.00, which was approved by the School Board in August 2016.

Our firm is including the following analysis to validate the Amendment # 07 request for Additional Service Fee:
