Non-responsive to the bid requirement that 'the Contractor must have a minimum of three (3) service technicians on staff who will respond to the SBSC at all times and within two hours for emergencies. Clarified by phone that technicians will need to be hired upon award and service technicians listed on form are in the Miami area. Does not currently have technicians that can respond within two hour window as per bid specifications.
Climate Control Mechnical Service	Non-responsive to the bid requirement that refrigeration repairs and installation of commercial kitchen refrigeration equipment must be the primary business of the Contractor for the past five (5) years as per bid specifications. Clarified by online website, HVAC is the primary business of this company.
