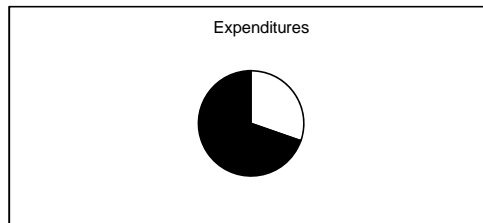


Internal Service Fund

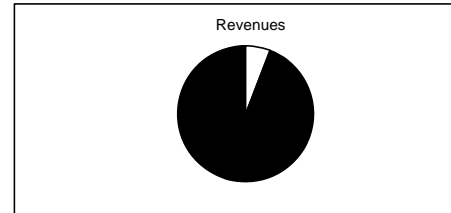

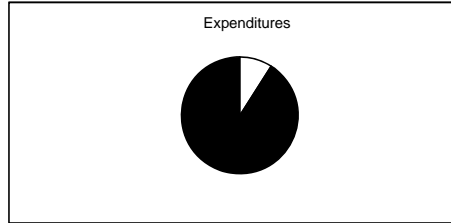
