The bid of The Bradenton Herald was the best low bid meeting the advertised specifications. The bid of Herald-Tribune Direct was non-responsive to the requirement to submit commercial references and a signed addendum. This bid is for a period of one year with the option to renew for two additional one-year periods. The funds for this purchase are contained in the operating budget allocated to the Adult and Community Education Department.
