Dear Mr. Pitcher:

As you requested, South Gate Utilities, Inc. is willing to make water utility service available to the North County Technical Center, in Sarasota County, Florida. It is our understanding that the project will construct new education buildings to replace the existing facilities.

As the Owner, Sarasota County School Board will be responsible for the construction and installation of all necessary on-site water distribution facilities such as water mains, hydrants, service lines, and other facilities reasonably required to provide adequate utility service to your project. All facilities will be interconnected by the Sarasota County School Board to our existing mains constructed in the Beneva Road right-of-way.

All facilities installed by Sarasota County School Board will be in accordance with all governmental specifications and in conformance with the construction standards utilized in our existing facilities. As the owner, Sarasota County School Board will indemnify our Company from any liability incurred during the installation of these facilities. All of the aforementioned facilities shall be owned and operated by Sarasota County School Board, up to the property line. All off-site facilities from the property line to the point of connection shall be transferred at no cost to our Company. Plans and specifications will be submitted to our Company for review, and shall have received the written approval of our Company before construction is begun, which approval shall not be unreasonably withheld or delayed.

We are willing to provide the requested utility service in consideration of an up front charge of \$300.00 for an Engineering Review Fee and a \$150.00 Inspection Fee. This fee calculation is based on your request for service as provided by an 8" connection to our existing 8" water main. It is South Gate Utilities' understanding there will be no increase in population; therefore no additional capacity is being requested. In consideration of this contribution, we waive all other tap fees/connection fees.
