The bid of Gator Grading and Paving, LLC, was the best low bid meeting the advertised specifications based on a sealed scenario. The bid of Advanced Asphalt of Southwest Florida, Inc., was non-responsive to the requirement of providing a lime rock base. This bid is for a period of one year with the option to renew for two additional one-year periods. Funds for these purchases are contained in the transfer from capital budget allocated to the Facilities Services Department.
