

## **Sarasota Summer Professional Development**

Key Supporting Rationale: Depth of Knowledge describes the fundamental shift in classroom practice, curriculum materials, and leadership observation and coaching within Florida's Standards. The new LAFS and MAFS (Florida's College & Career Ready Standards) have additional changes which impact both difficulty of content and the frequency of deeper cognitive instruction. Key standards in each grade level, in each discipline, should be taught earlier and more often based upon depth of cognition and impact on skill acquisition.

Assumption: Leadership team, as well as teacher teams, are unable to fully and effectively lead and implement instruction at deeper levels of cognition, and are unaware of and unprepared to implement the key high frequency standards, as well as the new LAFS and MAFS amended standards.

Approach: We will utilize a blended learning approach which leverages the existing resources within the district, which embeds consultation within authentic conversations already underway within the district, and which focuses on very specific pragmatic classroom actions.

**Content Access:** All content will be provided in a recorded .mp4 format along with the actual slides and other resources, for on-demand access by Sarasota teams, including new teachers and leaders.

**Pre-Summer Sessions:** We will provide access to online webinars which focus on Depth of Knowledge II and Depth of Knowledge III, as well as the use of the Deconstructed Standards (K-5, 6-12 for ELA and Math), as introductory sessions. We will also provide overview webinars of LAFS and MAFS (Florida's College & Career Ready Standards) for the purposes of background knowledge. (Eight recorded webinars total).
