- 1. DRC Review Process/County Coordination Attend meetings with Sarasota County staff, including pre-DRC meeting and follow-up coordination. Prepare plans for DRC review process. Prepare written response to DRC review comments and coordinate with BMK Architects, School Board staff, and Sarasota County staff.
- 2. Alternative Site Plan Coordinate with School Board staff and BMK Architects to develop alternative site plan options to maximize parking, circulation, and ingress/egress
- 3 Traffic Signal at Lords Avenue/Proctor Road Modify traffic signal plan to eliminate temporary signal approach (wood poles and strain wire)
- 4. Community Involvement Meetings Assist School Board staff and BMK Architects with questions raised by the community and attend community involvement meetings as requested. Prepare presentation exhibits
- 5. Additional Traffic Analysis Provide additional traffic analysis and recommendations related to the traffic signal at Lords Avenue vs. the traffic signal at the driveway accessing Proctor Road. Attend additional meetings with County staff and School Board staff.

6. Modifications to Proctor Road, Lords Avenue, and On-Site Improvements - Modify construction documents as a result of Sarasota County comments through the DRC process, including driveway modification at Proctor Road, modifications along Lords Avenue, parking lot modifications, buffer modifications, and other related items
