NON-EXCLUSIVE UTILITY EASEMENT -Lamarque Elementary School

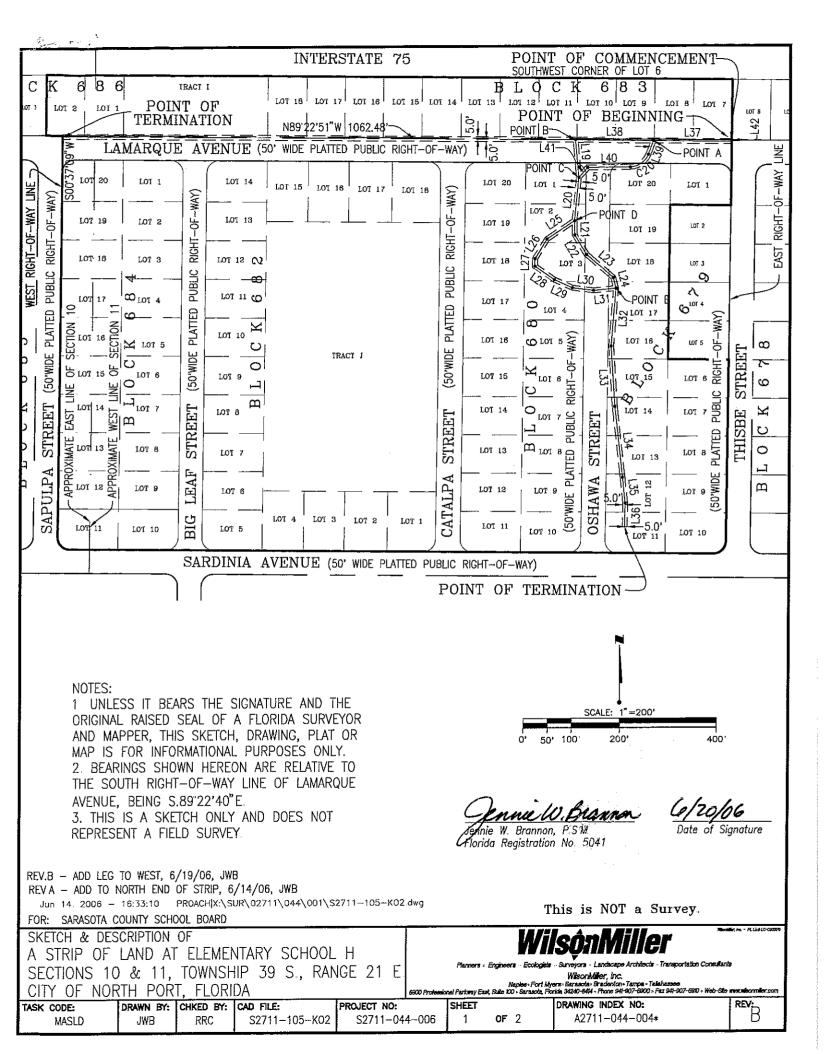
KNOW ALL MEN BY THESE PRESENTS that The School Board of Sarasota County, Florida, a body corporate existing under the laws of the State of Florida, whose address is 1960 Landings Boulevard, Sarasota, FL 34231, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, receipt of which is hereby acknowledged, do hereby grant to the Florida Power & Light Company, a corporation organized and existing under the laws of the State of Florida, whose address is 5657 South McIntosh Road, Sarasota, Florida 34233, its licensees, agents, successors and assigns, an easement for the construction, operation and maintenance of overhead and underground electric utility facilities (including wires, poles, guys, cables, conduits and appurtenant equipment) to be installed from time to time; with the right to reconstruct, improve, add to, enlarge, change the voltage, as well as the size of and remove such facilities or any of them within an easement ten (10) feet in width described as follows:

See Exhibit "A" attached hereto and made a part hereof

Together with the right to permit any other person, firm or corporation to attach wires to any facilities hereunder and lay cable and conduit within the easement and to operate the same for communications purposes; the right of ingress and egress to said premises at all times; the right to clear the land and keep it cleared of all trees, undergrowth and other obstructions within the easement area; to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or limbs outside of the easement area which might interfere with or fall upon the lines or systems of communications or power transmission or distribution; and further grants, to the fullest extent the undersigned has the power to grant, if at all, the rights herein above granted on the land heretofore described, over, along, under and across the roads, streets or highways adjoining or through said property

Commence at the southwest corner of Lot 6, Block 683, in the above mentioned Seventeenth Addition to Port Charlotte, said point being on the south right-of-way line of Lamarque Avenue (50-foot wide public right-of-way); thence S.00'42'45"W, a distance of 3.23 feet to the POINT OF BEGINNING; thence N 89'11'58"W, a distance of 161.73 feet to a point hereinafter referred to as POINT A; thence continue N 89'11'58"W, a distance of 161.02 feet to a point hereinafter referred to as POINT B; thence S 05'10'54"E, a distance of 77.99 feet to a point hereinafter referred to as POINT D; thence S.01'24'22"E, a distance of 29.43 feet; thence S 31'14'57"E, a distance of 47.51 feet; thence S 49'21'51"E, a distance of 73.13 feet; thence S 13'52'06"E, a distance of 22.58 feet to a point hereinafter referred to as POINT D; thence S 04'27'46"W, a distance of 120.59 feet; thence S 03'34'45"E, a distance of 125.89 feet; thence S 06'26'30"E, a distance of 148.97 feet; thence S 06'19'01"E, a distance of 53.71 feet; thence S 00'37'19"W, a distance of 49.87 feet to the POINT OF TERMINATION of said strip.

BEGIN at POINT A as described above; thence S 20°39′26″W, a distance of 29 96 feet to the point of curvature of a curve to the right having a radius of 40.00 feet and a central angle of 68°37′16″; thence southwesterly along the arc of said curve, an arc length of 47.91 feet to the point of tangency of said curve; thence S 89′16′42″W, a distance of 88.33 feet; thence S 41°39′06″W, a distance of 27.29 feet to the above mentioned POINT C

BEGIN at POINT B as described above; thence N.89°22'51"W., a distance of 1062.48 feet to the Point of Termination along a line which bears S 00°37'09"W

BEGIN at POINT D as described above; thence \$ 56°31'20"W, a distance of 68.48 feet; thence \$ 31°18'47"W, a distance of 46.99 feet; thence \$.00°37'19"W, a distance of 15.79 feet; thence \$.55°18'28"E, a distance of 48.85 feet; thence \$.65°46'56"E, a distance of 41.34 feet; thence \$.82°31'38"E, a distance of 44.03 feet; thence \$.84°19'29"E, a distance of 46.69 feet to the above mentioned POINT E;

The above described limits of said strip of land are to be extended or shortened as necessary to maintain a continuous 10.00—foot wide strip along the route described.
