Grant Purpose	The purpose of this grant is to assist adults in developing literacy skills, obtaining knowledge to assist in their children's educational development, completing high school or the equivalent, and preparing for post-secondary education and employment. The target population is adults, aged 16 and over, who are deficient in reading, math or language skills; lack a high school diploma; and/or are limited in English language proficiency.
Grant Activities	This grant will support classroom instruction to assist adults in developing basic literacy skills and preparing for a GED(R) high school equivalency diploma at multiple sites around the county. It will also support related career counseling services for students and professional development for staff.
Grant Budget Items	The budget provides salary for an administrative assistant and part-time (hourly) staff including instructors, teacher aides, and counselors; staff professional development and travel; contract with Literacy Council for tutoring services, membership in the Florida Adult Technical Distance Education Consortium for shared online instructional services; instructional supplies; and software.
