# **INTERAGENCY AGREEMENT**

This Agreement entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2017, effective July 1, 2017, by and between Girls Incorporated of Sarasota County ("Girls Incorporated") and The School Board of Sarasota County, Florida (the "Board").

**Purpose:** Provide research-based, age-appropriate programs to school age girls throughout Sarasota County during and after school in our facility and/or in Sarasota County Schools.

## Girls Incorporated of Sarasota County agrees to:

1. Provide the following research-based programs:

#### Girls Inc. Friendly PEERsuasion®

Girls Inc. Friendly PEERsuasion® develops girls' skills to resist pressure to use harmful substances including drugs, alcohol, tobacco, household chemicals, prescription and OTC medications. After learning healthy ways to manage stress and to deflect peer, media, and other pressures that contribute to substance use, girls may become peer educators for younger girls.

#### Girls Inc. Operation SMART®

Girls Inc. Operation SMART® builds girls' skills and interest in science, math, and technology. Hands-on activities give girls the opportunity to explore, ask questions, and solve problems.

#### Girls Inc. Media Literacy ®

Girls Inc. Media Literacy ® encourages girls to think critically about media messages and fosters their awareness of the scope and power of the media and its effects on girls and women.

#### Girls Inc. Economic Literacy ®

Girls Inc. Economic Literacy ® introduces girls as young as six to basic financial concepts, including money management and investment. The program explores how money affects us locally and globally as it fosters development of the skills needed to be financially self-sufficient.

#### Girls Inc. Project Bold®

Girls Inc. Project Bold® is a violence prevention and self-defense program that encompasses risk avoidance, safety, and social change.

#### Girls Inc. Sporting Chance®

Girls Inc. Sporting Chance helps girls appreciate an active lifestyle as they develop movement and athletic skills, cooperative and competitive spirit, health awareness, and interest in sports and adventure activities. Girls On The Run combines life skills development with 5K preparation.

#### **High School Initiative**

Our High School Initiative works with girls in high school to assist them in three key areas: healthy living, academic support and enrichment, and life skills. Girls participate in group and one-on-one mentoring sessions. The program includes identifying career goals, both vocational and academic, locating a school which will meet their goals, and guiding them in completing post-secondary admission and scholarship forms. Services include non-traditional career counseling, job-seeking and job-keeping skills, career exploration and planning, study skills, education planning, scholarship and financial aid seeking, and FAFSA application assistance. Healthy stress relief and coping skills, fitness and nutrition, social skills and emotional skills are also addressed.

#### **Girls Circle**

Girls Circle is a researched-based program that fosters self-esteem, helps girls develop and maintain healthy relationships with peers and adults, helps girls gain greater awareness of their options, and strengthens their ability to make choices that are consistent with their values, interests, talents and goals. This program uses hands-on and interactive activities such as games, role plays and art projects to reinforce the topics. Topics include Friendship, Body Image, Honoring our Diversity, Relationships with Peers, Paths to the Future, Being a Girl, Expressing My Individuality, Who I Am, and Mind-Body-Spirit.

- 2. Provide referral to resources in the community and to act as an advocate.
- 3. Provide services to a total of 400 girls including elementary, middle and high school girls.
- 4. Assure that all volunteers, employees or agents who will be present on school grounds will be fingerprinted and have their backgrounds checked as provided by Florida law. Girls Incorporated will furnish the results of all background checks to The Board before any of its volunteers, employees or agents will be permitted on school grounds while students are present. Girls Incorporated will further immediately furnish to The Board any notifications of arrests it receives with respect to volunteers, employees or agents who are present on school grounds. Girls

Incorporated will bear the cost of the fingerprinting/background checks. The Board has the right to refuse entry onto its school grounds to any individual whose background check does not meet the requirements established by The Board pursuant to Florida law. Like other visitors to school grounds, Girls Incorporated volunteers, employees or agents will also be subject to RAPTOR screening on school campuses. Additionally, any mentor must sign in and out of the school district's Volunteers Count! database each time they are on campus to mentor.

5. Hold harmless, indemnify, and defend the Board, its agents, servants, employees, in their official and individual capacity, from any demand, claim, suit loss, cost, expense or damage which may be asserted, claimed or recovered against or from the Board, its agents or employees, in their official or individual capacity, by reason of any damage to property or injury or death of any person which arises out of, is incident to, or in any manner connected with this Agreement. This provision shall survive termination of this Agreement and shall be binding on the parties, successors, representatives and assigns and cannot be waived or varied. Nothing in this provision is intended to waive any sovereign immunity to which the

Board may be entitled.

6. Provide a minimum of \$500,000 comprehensive general liability insurance naming the Board as an additional insured. As evidence of such insurance coverage, Girls Incorporated shall furnish The Board with a Certificate of Insurance prior to commencing services under this Agreement.

## The School Board agrees to:

- Provide, upon securing appropriate parental consent, access to girls at Booker, Riverview, Sarasota, Venice, North Port and Suncoast Polytechnical High Schools who have a GPA of at least 2.00 and who do not actively seek out guidance services, as well as elementary and middle school girls at Booker Middle, Brookside Middle, McIntosh Middle, Sarasota Middle, Pine View School, Laurel Nokomis School, Heron Creek Middle, Venice Middle, Woodland Middle, Bay Haven Elementary, Gocio Elementary, Ashton Elementary, Southside Elementary, Phillippi Shores Elementary, Gulf Gate Elementary, Tatum Ridge Elementary, Cranberry Elementary, Atwater Elementary, Glenallen Elementary, Toledo Blade Elementary, Lamarque Elementary, Garden Elementary, Venice Elementary, and Englewood Elementary.
- 2. Provide a facility on the each of the above-named campuses to meet with the identified students.
- 3. Provide, upon securing appropriate parental consent, access to student information, i.e., demographics, schedule, grades, test scores and attendance.
- 4. Upon securing appropriate parental consent, provide Girls Inc. the student's report card.

- 5. Support increased partnerships between Girls Inc. of Sarasota County & Sarasota County Schools for extended outreach programming within the schools. The School Board allows schools to:
  - a. Recommend and recruit girls to participate in annual programming.
  - b. Provide physical space on the campus for implementing outreach programming.
  - c. Provide a (school) faculty member to act as a liaison and/or to directly participate in the implementation of Girls Inc. Programming.
  - d. Coordinate with parents to promote family nights and other Girls Inc. events.

### Both Parties agree:

- 1. There will be no cost to the Board for Girls Incorporated providing services hereunder.
- 2. That Girls Incorporated is at all times acting and performing as an independent contractor in the performance of all obligations hereunder.
- 3. This Agreement shall be governed and construed in accordance with the laws of the State of Florida, and sole and exclusive jurisdiction for any action shall be in the Twelfth Judicial Circuit in and for Sarasota County, Florida.
- 4. Any additions, changes, deletions or modifications to this Agreement must be agreed upon in writing by both parties.
- 5. This Agreement shall commence July 1, 2017, and terminate June 30, 2018. Either party may terminate this Agreement at any time without cause by giving thirty days written notice to the other party.
