

**SECOND ADDENDUM TO CONTRACT FOR EDUCATIONAL SERVICES  
FLORIDA CENTER FOR CHILD AND FAMILY DEVELOPMENT, INC.**

THIS SECOND ADDENDUM is entered into this 5<sup>th</sup> day of June, 2007, by and between The School Board of Sarasota County, Florida, a body corporate under the laws of the State of Florida (the "Board") and Florida Center for Child and Family Development, Inc., a Florida corporation (the "Child Development Center").

R E C I T A L S

A. The parties hereto entered into a contract for educational services for eligible exceptional students (the "Contract") on July 19, 2006, expiring June 30, 2007.

B. The parties are contemporaneously entering into an Addendum to Contract dated June 5<sup>th</sup>, 2007 (the "Addendum"), adding extended school year services for June 2007 and increasing the total reimbursement for services not to exceed \$372,260.00.

C. The parties hereto desire to further modify the Contract to permit services to be provided during an Extended School Year (ESY) during July 2007 for up to an additional 12 school days and to provide compensation therefor under the following terms and conditions.

NOW, THEREFORE, in consideration of the mutual promises made herein, the parties do hereby agree as follows:

1. Paragraph 4C of the Contract is amended so that it shall now terminate on July 31, 2007.

2. Paragraph 3D of the Contract is amended to include an additional provision of Extended School Year (ESY) Educational Services for an additional 12 school days during July 2007. Compensation for shall be at the rate of \$53.00 per student per

day for 12 school days during July 2007.

3. Paragraph 3D of the Contract is further amended so that the ESY services in July 2007 may be compensated as stated in paragraph 2 above. The cost of these additional ESY services shall not exceed \$22,260.00, and shall be in addition to any other amounts already listed in paragraph 3D.

4. The parties acknowledge and agree that the remainder of the terms of the Contract and Addendum thereto shall remain in full force and effect during the term of this Second Addendum.

5. Where there is any conflict between the terms of this Second Addendum, the Addendum and the Contract, the terms of this Second Addendum shall control.

IN WITNESS WHEREOF, the parties have executed this Second Addendum as of the date first above written.
