

## Proposed edits for Venice Golf and Country Club and Myakka Estates

### **GARDEN ELEMENTARY:**

From U.S. Highway 41 at Curry Creek, east along Curry Creek to the junction of Curry Creek and Venice city limits. Follow the Venice city limits east, then north to include all of Capri Isles, Pinebrook South, Eastgate Terrace, Colonial Manor, Ridgewood, Bird Bay, and Waterford subdivisions. East, then south along Venice city limits to Border Road. East on Border Road to I-75. (All streets with access from Border Road are in Taylor Ranch.) Southeast on I-75 to Jacaranda Boulevard. South on Jacaranda Boulevard to a point due west of Rich Street. East from this point to the northeast property boundary of the Chestnut Creek Subdivision. ~~Rich Street. East on Rich Street to Havana Road. South on Havana Road on an imaginary extension~~ South along the eastern property boundary of the Chestnut Creek Subdivision to Center Road. East on Center Road to a point north of the terminus of Meadow Run Drive. (All of Chestnut Creek, East Village, Jacaranda West in Garden. New developments east of these areas including Venice Golf and Country Club are in Taylor Ranch.) South from this point to an imaginary extension of Alligator Creek. Southwest along this extension of Alligator Creek to Alligator Creek. Southwest along Alligator Creek to U.S. Highway 41 (Tamiami Trail). Northwest on U.S. Highway 41 to U.S. 41 By-Pass. North on U.S. 41 By-Pass to Curry Creek.

### **TAYLOR RANCH ELEMENTARY SCHOOL:**

From I-75 at Border Road, east on Border Road to Jackson Road. (Both sides of Border Road and all streets with access from Border Road are included in Taylor Ranch. NOTE: This is true also for the portion of Border Road east of the Myakka River.) North on Jackson Road to Palm Drive. East on Palm Drive to its termination. Due east from the termination of Palm Drive to the Myakka River. South and southeast along Myakka River to a point ~~due~~ just southeast of Manasota Beach Road (All of the Myakka Estates Subdivision is in Taylor Ranch). Northwest from this point to the intersection of ~~along~~ an imaginary extension of Manasota Beach Road to Manasota Beach Road at the southeastern corner of the Pennington Place subdivision. North along the subdivision's property line to the eastern end of the storm water pond south of Pierce Drive. West through the pond to State Road 776. North to the drainage canal south of Ponderosa Road. West through the canal to the northern tip of Manasota Key. North through Lemon Bay to Alligator Creek. East and northeast along Alligator Creek to an imaginary extension of Alligator Creek to a point south of the terminus of Meadow Run Drive. North from this point to Center Road. West on Center Road to the eastern boundary of the Chestnut Creek Subdivision. North to the northeast property boundary of the Chestnut Creek Subdivision then west a point south of Havana Road. ~~North on an imaginary extension of Havana Road to Rich Street. West on Rich Street to an imaginary extension of Rich Street to Jacaranda Boulevard. (Both sides of Rich Street to Taylor Ranch).~~ North on Jacaranda Boulevard to I-75. North on I-75 to Border Road. Also includes the area bounded on the east by the Sarasota/Charlotte County line, the south and west by the Myakka River, and the north by the city limits of North Port.
