Johnson & Son, Inc., was the best low bid meeting the advertised specifications based on a sealed scenario. The bid of Above All Structural, LLC, was non-responsive to the requirement to provide these services under the same legal entity for a minimum of three years. This bid is for a period of one year with the option to renew for two additional one-year periods. The funds for these purchases are contained in the capital budget allocated to the Construction Services Department.
