SECOND ADDENDUM TO CONTRACT FOR EDUCATIONAL SERVICES between the School Board of Sarasota County, Florida and Community Haven for Adults and Children with Disabilities, Inc. D/B/A Selby Preschool

THIS SECOND ADDENDUM is entered into this 1st of May 2018, by and between The School Board of Sarasota County, Florida, a body corporate under the laws of the State of Florida ("the Board"), and Community Haven for Adults and Children with Disabilities, Inc, d/b/a Selby Preschool ("Selby Preschool").

RECITALS

- A. The parties hereto entered into a Contract for educational services for eligible exceptional students (the "Contract") on July 18, 2017, expiring June 30, 2018, for services through May 2018.
- B. The parties entered into an Addendum to the Contract on August 15, 2017, to update the matrix and total reimbursement amounts.
- C. The parties hereto desire to further modify the Contract to permit services to be provided during an Extended School Year (ESY) in June 2018, and for up to an additional 8 school days during July 2018, and to provide compensation therefor under the following terms and conditions.

NOW, THEREFORE, in consideration of the mutual promises made herein, the parties do hereby agree as follows:

- 1. Paragraph 4C of the Contract is amended so that it shall now terminate on July 31, 2018.
- 2. Paragraph 3D of the Contract is amended to include for the provision of services in June 2018. The June 2018 services will be paid for with the funds already included in the Contract.

3. Paragraph 3D of the Contract is amended to also include the provision of Extended School Year (ESY) Educational Services for an additional 8 school days during July 2018. Compensation shall be at the rate of \$58.00 per student per day for 8 school days during July 2018.

4. Paragraph 3D of the Contract is further amended so that the ESY services in July 2018 may be compensated as stated in paragraph 3 above. The cost of these additional ESY services for July 2018 shall not exceed \$4,640.00 and shall be in addition to any other amounts already listed in paragraph 3D.

5. The parties acknowledge and agree that the remainder of the terms of the Contract and Addendum shall remain in full force and effect during the term of this Second Addendum.

6. Where there is any conflict between the terms of this Second Addendum and the Contract and Addendum, the terms of this Second Addendum shall control.
