You advised me in mid-November that there were changes being considered by the owner for all three administration buildings at Laurel Nokomis, Booker Middle School and Sarasota Middle School. On November 28, 2017 we met at Laurel Nokomis School with SBSC staff, on December 20, 2017 we met at Booker Middle School with SBSC staff and on January 17, 2018 we met at Sarasota Middle with SBSC staff. Please consider this an amendment to our agreement with MES dated 5/26/17.

Generally, the program was enhanced to open the wall to Room 105 between it and the Administration Lobby, subdivide Room 105 with a six foot high drywall partition (structurally supported with cantilever steel post similar to administration Lobby walls), indicate a fixed glass window between Room 105 and the Clinic, note that the door to exterior in Room 105 is to have a controlled access, indicate that the door at the end of Hall 131 is to have controlled access, locate call buttons at the exterior entry doors, indicate that the new entry counter will have two work stations fitting in the space remaining after a low door and the security wall were proposed. The ceiling, lighting and AC will remain as is in Room 105. There was discussion to increase the height of the existing 8' high cantilevered wall to 10' but after subsequent conversation it was determined to leave this at 8' so as not to interfere with the AC system in the Lobby. Dear Josh,

You advised me in mid-November that there were changes being considered by the owner for all three administration buildings at Laurel Nokomis, Booker Middle School and Sarasota Middle School. On November 28, 2017 we met at Laurel Nokomis School with SBSC staff, on December 20, 2017 we met at Booker Middle School with SBSC staff and on January 17, 2018 we met at Sarasota Middle with SBSC staff. Please consider this an amendment to our agreement with MES dated 5/26/17. This amendment will not modify the fencing portion of the agreement.

Generally, the program was enhanced to open the wall to Room 105 between it and the Administration Lobby, subdivide Room 105 with a six foot high drywall partition (structurally supported with cantilever steel post similar to administration Lobby walls), indicate a fixed glass window between Room 105 and the Clinic, note that the door to exterior in Room 105 is to have a controlled access, indicate that the door at the end of Hall 131 is to have controlled access, locate call buttons at the exterior entry doors, indicate that the new entry counter will have two work stations fitting in the space remaining after a low door and the security wall were proposed. The ceiling, lighting and AC will remain as is in Room 105. There was discussion to increase the height of the existing 8' high cantilevered wall to 10' but after subsequent conversation it was determined to leave this at 8' so as not to interfere with the AC system in the Lobby. Field verification of existing conditions is included.

In addition to the above, the Clinic closet between Room 105 and the Clinic will be demolished and replaced with a low counter below the sill of the new window from room 105 to the Clinic. In Room 109 the overhead coiling window and stainless-steel counter is to be removed and replaced with a fixed glass window.

A request has been made to modify the security design improvements for this school. Please consider this an amendment to our May 26, 2017 Proposal letter to ME&S.

Scope of Architectural and Engineering Services:

The modifications will include adding glass in front of the reception area in order to physically isolate the visitors from staff and students.

This glass may vary in resistance and will be confirmed by the School Board. Use standard School Board details and products for ballistic resistant requirements.

Specify bullet resistant trays at the receptionist station or as approved by the School Board. Use standard detail provided by School Board. Review location of this material with School Board.

Specify bullet resistant tiles at the receptionist station or as approved by the School Board. Use standard detail provided by School Board. Review location of this material with School Board.

The previous layout of new walls and doors at the entry lobby are to be modified to accommodate the separation of visitors from school staff.

Existing cabinetry will only change as required to meet ADA and a single staff/visitor station. Modify existing drywall partitions adjacent to counter top to provide additional visibility to the new student seating and to visitors.

Security doors from the Administration work space to the adjacent halls will not be required Indicate/design ADA counter on visitor's side of receptionist desk for sign-in sheets.

Counter top at receptionists to comply with ADA. It will be modified as required.

Speaker/communication system will be specified for receptionist/visitor communications as approved by School Board.

Changes to incorporate room 105/Clinic will not change. Indicate vertical blinds at new window. Doors and or glazing for the Buildings 2, 3 and 5 will be changed to the School Board standard as directed.
