## BILL OF SALE

All pipelines, pipes, tees, manholes, connections, cut-offs, fire hydrants, valves, lift stations and all other equipment used or useful for and/or in connection with the water distribution system and wastewater collection system constructed and installed by the party of the first part in and on the subdivision and lands described as follows:

## ELEMENTARY SCHOOL "I"

It is the purpose and intent of the parties of the first part to convey to the party of the second part of this Bill of Sale all property comprising said water supply distribution system and wastewater collection system to and within the above described property, together with all of the rights of the party of the first part arising out of any and all guarantees, performance bonds, contracts and agreements of the party of the first part in connection with said water supply distribution system and wastewater collection system
