# CONNECT 24 SERVICES SCHEDULE 1 (United States)

# **Cellular Transmission Services**

This Service Schedule 1 ("*Schedule*") to the Master Reseller Agreement ("Agreement") between Connect 24 Wireless Communications, Inc. ("*Connect 24*") and Reseller specified below ("*Reseller*") is effective on the date which Connect 24 signs the Schedule. The Services provided by Connect 24 to Reseller shall be governed by the terms of the Agreement, which are incorporated herein by reference. In the event of any conflict between the terms of this Schedule and the Agreement, the terms of this Schedule shall control with respect to the Services covered by this Schedule. Capitalized terms used herein and not otherwise defined shall have the meanings set forth in the Agreement.

## 1. <u>GSM Services</u>.

Provides a communication path (primary or backup to an alternate path) for a premises alarm system (DSC or other compatible device) to communicate system events to a central monitoring station. Also used to provide additional services such as end-to-end supervision and panel upload/download capabilities as supported by the DSC wireless communicator installed.

#### a. Billing

- All account activations for a given month will be invoiced at the end of that month. Billing is automatic upon activation. (i.e.: Each new account will be invoiced at \$5.00 + (monthly rate)).

- All amounts are in US Dollars.
- Cancellation of End User Accounts. All accounts must be terminated in writing to CONNECT 24 or via the Connect 24 website.



- Any End User account cancelled within a month will be subject to the full monthly fee for the month of such cancellation. No refunds or pro rating of the monthly fee will be made by Connect 24 for cancelled accounts.
- If an account is cancelled, prior to the receipt of payment, all monies for services already provided (months used, in whole or in part) is immediately due.
- Cancellation of account will also cancel all additional services with a dependency on this service (i.e. 2-way voice, SMS Command and Control)
