# TITLE: APPROVAL TO AWARD BID #19-0031 FOR COMMERICAL, METAL, & SHINGLED ROOF INSTALLATION & REPAIR SERVICES

Bids to provide 'Commercial, Metal, & Shingled Roof Installation & Repair Services' were received from eight vendors on October 11, 2018. The bids of Crowther Roofing & Sheet Metal of FL, Inc., Gulf States Industries, Inc., Ryman Construction, Inc., Springer-Peterson Roofing & Sheet Metal, Inc., and Sutter Roofing Company of Florida were the best overall low bids meeting the advertised specifications based on a sealed scenario. The bid of A-1 American Roofing & Sheet Metal, Inc., was non-responsive to submitting a bid bond per the bid specifications. This bid is for a period of three years with the option to renew for two additional one-year periods. The funds for these purchases are contained in the budget allocated to the Facilities Services Department.
