The bids of Gulf Coast Signs of Sarasota, Inc., Rocal, Inc., and Signs 2 Go, Inc., were the best low bids meeting the advertised specifications per category based on a sealed scenario. The bids of H & H Signs, Inc., and Municipal Supply and Sign Company were non-responsive to the maximum materials mark-up as per the bid specifications. This bid is for a period of one year with the option to renew for two additional one-year periods. The funds for these purchases are contained in the transfer from capital budget allocated to the Facilities Services Department.
