## CONTRACT AMENDMENT NO. 2 TO HOSTING SERVICE AGREEMENT

This Contract Amendment made and entered into upon execution by both parties by and between SARASOTA COUNTY, a political subdivision of the State of Florida, hereinafter referred to as the "COUNTY," and, the School Board of Sarasota County, hereinafter referred to as "SCHOOL BOARD."

## <u>WITNESSETH</u>

WHEREAS, the COUNTY and the SCHOOL BOARD entered into a contract for the provision of hosting and related technology services ("Contract"), dated March 29, 2010, and a Contract Amendment No. 1, dated August 17, 2010; and

WHEREAS, the COUNTY now requires to amend the Contract to clarify the services being provided.

NOW THEREFORE, the COUNTY and SCHOOL BOARD in consideration of the mutual covenants contained herein, do agree to amend the Contract as follows:

- 1. In Terms and Conditions, Section D., 1, Payment of Fees: the amount is changed from \$202,168.58 to \$213,997.53, due and payable in monthly installments. The monthly installments are changed from \$16,847.38 to \$17,833.13.
- 2. In Section L line 3: add "Archibus Agreement #2005-475."
- In Exhibit A, Section V, Sarasota School Board Environment, Line
  Add "Archibus."
- 4. In Exhibit A, Section IX, titled Services Provided, C., Line 1: add "Archibus."
- 5. Exhibit C is hereby replaced in its entirety with the Exhibit C attached and made a part of this Amendment.
- 6. Except as modified herein, all other terms, covenants, and conditions of the Contract and Contract Amendment No. 1 shall remain in full force and effect.
